



POSTDOCTORAL RESEARCH FELLOWS - Pros and Cons of different Visa Types October 2021

Overview: Postdoctoral Research Fellows (PDRFs) are required to register as postdoctoral researchers at the University of Cape Town (UCT) via the PeopleSoft administration system. A part of the registration requirements for the International fellow is to (1) Pre-register (a visa and immigration clearance process) followed by (2) Registering with the Faculty. Additional information is captured below on page 5 under *important notices and visa matters*

All international researchers who will be a resident in the Republic of South Africa (RSA) for their research are required to have a relevant visa for the duration of stay in the Republic. First time visa applications (study; visitor's visa for research; critical skills) are obtained from the South African Embassy, High Commission or Consulate in your home country. You will need to refer to the application requirements on their website. Your *visa always needs to be valid* and allow you multiple entry into South Africa.

These requirements may vary from country-to-country; therefore, we recommend that you contact the Consular Office at the [South African Mission Abroad](#) in your home country to confirm the requirements.

Note: You *CANNOT change from a tourist/visitor's visa* to any other visa type from within South Africa.

In the Republic of South Africa (RSA), the Department of Home Affairs (DoHA) has officially outsourced the handling and processing of visa applications to a company called Visa Facilitation Services (VFS) Global. The Visa Application Centres (VFS) Global are in major cities across the world. It is important to note VFS Global does not have the authority to grant or refuse visas. VFS Global only accepts the visa applications on their behalf of DoHA. The adjudication and decision to ultimately issue a visa is by the DoHA.

There is no one prescribed visa for PDRFs, they can register with a study visa, visitor's visa for research or a critical skills visa.

NOTE: If your area of research and qualification is not on the list of critical skills, you will need to apply for a study visa or an endorsed visitor's visa to cover the postdoctoral fellowship.

All applications accepted from the Visa Facilitation Centre will have a minimum processing time of 8 – 10/12 weeks pending the outcome from the DHA. You can track your application online on the VFS Global website to determine the status of your application.

Note: Due to the Covid pandemic, processing timelines will vary due to office closures in accordance with Government Covid regulations. Please check by asking at the Embassy/Mission/Consular/VFS offices when submitting the application.

We advise that applications for *new study visas* should be *submitted at least 12 weeks before the intended departure date* for UCT, as it takes time to process these applications. Applications for a new Study visa is issued at Missions in your home country.

Note: Due to the Covid pandemic, processing timelines will vary due to office closures in accordance with Government Covid regulations. Please check by asking at the Embassy/Mission/Consular/VFS offices when submitting the application.

The details below are meant to facilitate a comparison between the pros and cons of the different visa types.

This will depend on whether you have resided in or travelled through a Yellow Fever endemic area. 11. A letter of undertaking from the International Academic Programmes Office of UCT. To receive a letter of undertaking to support the visa (study or visitors visa for research) please complete <i>section A, B and C</i> of the Letter request webform 13. In the case of bilateral agreement, a foreign state accepts responsibility for the applicant in terms of a written undertaking to pay for the departure of the applicant. 14. Proof of medical cover with a South African medical aid provider registered with the South African Council of Medical Schemes. For more information about Health Insurance NB: The medical aid cover must be active from the expected date of arrival until 31 December in a given academic year. Medical cover is renewed annually for the validity period of your study visa. 17. Proof of sufficient financial means to cover subsistence and incidental costs, in the form of a bank statement. 18. A return plane ticket (if fellowship is less than one year). 19. Details regarding arranged accommodation, if any. <p>Please note that the documents must be originals or certified copies.</p> <p>* A certified copy is a photocopy of the original document with an original certified stamp indicating that the authorised person, e.g. a Commissioner of Oaths or police officer, has seen the original document.</p> <p>Note: An uncertified photocopy of the original or a photocopy of a certified copy is not sufficient.</p>	<ul style="list-style-type: none"> ✓ open bank account ✓ invite family members. ✓ work 20-hours per week. ✓ Compared to visitor's visa, there is longer duration before renewal i.e., 60-days from expiration. ✓ When renewing the study visa, only requires police certificate for South Africa, after being in South Africa for more than one year. A written undertaking by the employer to ensure that the passport of his or her employee is valid at all times for the duration of his or her employment (where there is no employer: a written undertaking by the applicant to ensure that the passport of the applicant shall be valid at all times for the duration of his or her temporary visa)</p> <p>15. For the occupations listed under the Critical Skills category of: i) life and earth sciences; and ii) academics and researchers, you are required to provide proof of suitable financial means, if you do not have an employment contract. You will also be required to continue to prove your financial means every year subsequent to receiving your critical skills visa with no work contract.</p> <p>16. Proof that the applicant falls within the critical skills category by specifically indicating the occupation/critical skill for which the application is being made as it appears on the critical skills list.</p> <p>17. Proof of evaluation of the foreign qualification by SAQA and translated by a sworn translator into one of the official languages of the republic.</p> <p>18. If required by law, proof of application for a certificate of registration with the professional body, council or board recognised by SAQA in terms of section 13(1)(i) of the national qualification's framework act;</p> <p>19. <p style="text-align: center;">IMPORTANT NOTICES AND VISA MATTERS</p> <ul style="list-style-type: none"> PDRFs require an official letter from the academic host at UCT confirming continuance of research at UCT, the terms of the fellowship, the amount of the fellowship award and the duration for which an extension is required. PDRFs moving to South Africa with their children will be required to purchase medical aid cover for their children, regardless of the type of visa held by the PDRF. PDRFs married to South Africans and on spousal visas are allowed to register as postdoctoral fellows. Critical Skills Application requirements: 5 years' proven Skills and experience in field on the Critical Skills lists; to be registered with Professional body SAQA or Government department in field of classification. Proof of foreign qualification. Critical Skills Certificate registrations must be renewed annually-if not maintained it will lapse technically and therefore no longer valid. A spouse and dependent children of a holder of a critical skills work visa shall be issued with an appropriate visa valid for a period not exceeding the period of validity of the applicant's critical skills work visa. PDRFs who completed their doctoral studies in South Africa, who are applying for critical skills visas are advised to apply for South African permanent residence in parallel with their critical skills visa, if they desire permanent residence. <p>** Applicants must have a work offer, in order to apply for Permanent Residence**</p> <p>If both applications are made in parallel, the applicant receives a concession from having to submit supporting documents for their South African permanent residence application.</p> <p>Pre-registration verifies compliance with immigration and visa regulations. It is a requirement for all international students regardless of whether they travel to South Africa or not. Pre-registration is the administrative process for:</p> <ol style="list-style-type: none"> Verifying that an international student has the required immigration visa and study permit required for registration at UCT, and that the student has medical aid cover from a South African medical aid scheme for the full duration of their study visa; and Confirming that all initial fee payments i.e., the postdoctoral fellowship award letter <p>Both checks require the lifting of blocks to academic registration on students' records. Both pre-registration blocks are administered by the International Office. Once you have been pre-registered, the "blocks" on your profile is lifted allowing you to register with your faculty.
